#### **National Water Safety Award 2011**

Bill Mitchell from Thames Tradesmen's RC has won British Rowing's first National Water Safety Adviser Award.

Bill has been the driving force behind a revolution in safety on the Tideway in recent years. He led the group that drew up the Tideway Navigation Code and continues to work tirelessly to ensure that all rowers are aware of the code. Bill has also worked for over twenty years with the organisers of all the Tideway Head races, and provided safety advice at three World Rowing events at Dorney Lake. Bill was an umpire for over thirty years and developed a programme and trained nearly 100 umpires.

### **Safety Alert**

In September there was a serious incident involving a head-on collision between an VIII with traditional 3 stay riggers and a quad with 2 stay riggers. Both bow men were injured but it is believed the design of the riggers made a significant difference to the injuries suffered. The bow man of the quad was cushioned by the bow stay of the VIII and was only bruised. The bow man of the VIII was hit directly by the rowing pin of the quad's rigger. He was taken to hospital with substantial injuries including broken bones.

Clubs are encouraged to make all members aware of the consequences of collision involving 2 stay riggers and reinforce the importance of avoiding such collisions by following the local navigation rules, ensuring the competence of steers people and taking due regard of the conditions.

The British Rowing Water Safety Committee will review the safety aspects of 2 stay riggers and report back in due course.

## Club Water Safety Audit Due 31st December 2011

In October an email was sent to each Club Water Safety Adviser (CWSA) announcing the launch of the 2011 Club Water Safety Audit. As a recognised part of affiliation audit must be completed, submitted online and accepted by your Regional Water Safety Adviser (RWSA) no later than **Saturday 31**<sup>st</sup> **December 2011**. Please allow at least a week for your RWSA to review your submission. If there are legitimate reasons why your club will be unable to meet this deadline, it is essential that your RWSA is informed as soon as possible.

If you do not submit your audit or it is yet to be accepted by your RWSA on 31<sup>st</sup> Dec, your club will be suspended from entering competitions from 1<sup>st</sup> January 2012.
